

This Indenture made the ^{in the year of our Lord} twentieth day of June one thousand seven hundred and ninety three Between Rush Hudson and Lucy his wife of the one Part and Gerard Hotchkiss of the other Part Witnesseth that the said Rush Hudson and Lucy his wife for the Consideration of Ninety Pounds Lawful Money of Virginia to the said Rush paid do Bargain and sell to the said Gerard Hotchkiss and his heirs a certain Tract of Land lying and being in the County of Amherst containing by estimation one hundred and thirty Acres be the same more or less, being part of a larger Tract granted by Patent to Euler Braxton Esqr and since conveyed to other Persons Joshua Hudson bought it of Richard Gatewood and conveyed it to his son Rush by Deed of Gift which said one hundred and thirty Acres are bounded as followeth Beginning at Point in Joshua Hudsons line corner to William Cabell and with his line South one West one hundred and fifty Poles to Point then South thirty three West to Point sixty Poles then South two West forty six Poles to Point then South two East twenty eight Poles to Point then South twenty two East forty one Poles to Point in Samuel Merediths line and with it North sixty West fifty seven Poles to Point corner to Lindsey Coleman and with his line North twenty two West one hundred and sixty nine Poles to a red Oak then North fifty two East one hundred Poles to a red Oak then North thirty one East ninety one Poles to a red Oak corner to Joshua Hudson and with his line South forty east seven Poles to the Beginning To have and to hold the said Tract of Land with ^{all} appurtenances to the said Gerard Hotchkiss and his heirs to the sole use of the said Gerard Hotchkiss his heirs and assigns forever and the said Rush Hudson for himself and his heirs, doth Covenant with the said Gerard Hotchkiss his heirs and assigns that he the said Rush Hudson and his heirs the said Tract of Land and Premises to the said Gerard Hotchkiss and his heirs assigns shall and will warrant and forever defend by this Presents J M Widdells Whom of the said Rush Hudson & Lucy his wife hath hereunto set their hands and seals the day and ye as first above written

This Indenture made this seventeenth day of June in the Year of our Lord one thousand seven hundred and ninety three Between Thomas Johns and Nancy Johns of Amherst County of the one Part and John Jenkins of the same County of the other Part Witnesseth that the said Thomas Johns and Nancy Johns his wife for and in Consideration of the sum of thirty five Pounds to them in hand paid by the said John Jenkins the receipt whereof they do hereby acknowledge hath bargained and sold enfeoffed and confirmed unto the said John Jenkins one certain Parcel or Tract of Land containing Patent two hundred Acres lying and being in the County of Amherst on the North branches of Stovall Creek and bounded as followeth to wit Beginning at Point corner to his own and running thence with his own line South forty degrees East Eighty eight Poles to Point in George Stovall line and with it North twenty one Degrees east at one hundred and twenty eight Poles a Branch two hundred and thirty Poles a line the same corner Continued a new line twenty one Poles to a white Oak Sapling North thirty degrees West one hundred and forty Poles to a red Oak South sixty eight degrees West eighty Poles to Point in Joseph Browns line thence with it South nine Degrees West at forty Poles a branch one hundred and nine Poles to a red Oak Sapling in his own line and with them South eighty six Degrees East eleven Poles to a Hickory Sapling South twelve degrees East at twenty six Poles a branch at thirty eight Poles Stovall Creek at forty four Poles the said Creek one hundred and fifteen Poles to Point South two Degrees West forty Poles to the Beginning To have and to hold unto the said John Jenkins him and his heirs forever with all the Dwelling houses out houses orchards and all appurtenances thereto belonging and the said Thomas Johns and Nancy Johns his wife doth and will warrant and defend the said parcel or tract of Land to the said John Jenkins and his heirs forever from the Claim of a Claims of all and every Person or Persons whatsoever In Witness whereof the said Thomas Johns & Nancy his wife hath hereunto set their hands and affixed their seals the day
